#### **BACKGROUND:**

The JPA reserve policy was approved in 2010. This policy addresses two situations for establishing and managing a separate reserve fund: 1) accrued staff vacation time; and vehicle/equipment replacement. However, the current policy lacks some broader purposes and management of a reserve fund, for example operating reserves in the case of revenue shortfalls or unexpected expense overruns and emergency situations.

At its September, 2019 meeting, the Board directed staff to develop a revised Reserve Policy for its review and adoption by the end of the calendar year.

Staff researched example reserve policies of other agencies and received input from counsel. Staff is bringing the attached draft Reserve Policy before the Board at this time for review, input and possible adoption.

1) Review and provide recommendations for the attached Reserve Policy and adopt as revised.

# SAN DIEGUITO RIVER VALLEY REGIONAL OPEN SPACE PARK JOINT POWERS <u>AUTHORITY</u>

#### **RESERVE POLICY**

#### I. Purpose

The San Dieguito River Park Joint Powers Authority (JPA) is committed to prudent fiscal practices and maintaining adequate operating and capital replacement reserve funds to ensure consistent, uninterrupted park services and facilities in the wake of potential risk events, such as a major economic downturn or natural disaster. The capital replacement reserve is also for the regular replacement of vehicles and equipment as well as any significant infrastructure replacement or renovation, retrofit or upgrade to park buildings and facilities. This policy provides additional clarity and guidance with regard to the JPA's management of it reserve funds and supersedes Policy 10-02 San Dieguito River Park Joint Powers Authority Reserve Policy, dated May 21, 2010.

#### II. Operating Reserve Fund

The JPA will continue to hold an identified operating reserve in two accounts and report on its status periodically to the Board of Directors. These reports may be made quarterly, during the annual budget process and/or when a significant change (e.g. market conditions) occur. One account is held at the County Treasury and is constituted of any annual budget surplus carryover from one fiscal year to the next. The other operating reserve is held at the Rancho Santa Fe Foundation (RSFF) in the form of a non-endowment account.

#### A. Operating Fund Reserve Target

The target for operating reserves is a cumulative balance at 33% of the budgeted annual operating fund expenditures.

#### B. Operating Fund Reserve Uses

The operating fund reserve may be used for the purposes of maintaining cash flow to support critical functions identified in the annual operating budget as designated by the Executive Director and Board of Directors in the event of significant unanticipated revenue shortfalls. The fund may also be used for unanticipated costs approved by the Board of Directors, such as major litigation, spikes in pension contributions, market volatility, unplanned capital needs or other opportunity costs.

#### III. Capital Replacement Reserve Fund

Reserve funds identified for capital replacement exist in two accounts held by the JPA and come from various sources. The JPA holds a capital reserve fund at the County Treasury which receives scheduled deposits annually as part of its operating budgets for general park capital equipment. The JPA also holds a restricted non-endowment fund at the RSFF specifically for trail repairs and upgrades in the Santa Fe Valley portion of the Coast to Crest Trail.

A. Capital Replacement Fund Targets (general)

The general capital replacement fund target(s) will be assessed annually based on the inventory of vehicles, large equipment and facilities. Using the anticipated lifespan for such capital assets, the Executive Director will propose the annual budget contributions necessary for future replacement. These amounts will be deposited into the JPA's capital reserve fund at the County Treasury. Internally, JPA staff may track sub-accounts within this fund to correspond with original funding sources as appropriate.

B. Capital Replacement Fund Target (Santa Fe Valley Restricted)
This fund is restricted to trail repairs and upgrades in the Rancho Santa Fe Valley portion of
the Coast to Crest Trail. It is a non-endowment account held at the RSFF and is intended to
generate interest to maintain and/or grow it initial balance. There are no anticipated
deposits by the JPA expected to made to this fund for its purposes. Instead, the JPA may
periodically withdraw from this account to fund staff, equipment, materials, contractors or
other Board-approved items in line with the restrictions of this fund.

#### III. Reserve Administration

The following is provided for appropriate and timely administration of the JPA Reserve Fund.

- A. The JPA's overall reserve funds referenced above will be reported and adjusted annually during the budget process.
- B. Any funds in excess of the amounts referenced in II. A. and B. above may be identified at the close of each fiscal year for programming at the Board of Directors' discretion.
- C. If, based on staff's forecasting and analysis, the fund targets are not being met or will not likely be met within a two-year time horizon, the Executive Director will work with the Budget Subcommittee of the Board of Directors to develop a plan to achieve the target outline in this policy.
  - D. The target levels will also be assessed periodically may be revised based on staff and Budget Subcommittee recommendation to the Board of Directors.

#### IV. Authority to Use Reserves

- A. Use of the reserves shall be consistent with the purposes and provisions contained within this policy.
- B. Any use of annual operating funds that would cause the JPA's reserve to drop below the targets stated in this policy shall be permitted only on a specific, case-by-case basis as authorized by the Board.

#### V. Replenishment of Reserves

- A. In the event use of the reserves that drops a fund below the targeted level, the Executive Director shall propose a plan for the replenishment of the reserves to the Board as soon as practicable.
- B. The JPA will strive to replenish the reserves within one year of use, but fully replenish the reserve within five years of use.
- C. The JPA will seek reimbursement from any appropriate sources to replenish reserves used in connection with a catastrophic event (e.g. Federal Emergency Management Agency (FEMA)).

#### VI. Risk Mitigation Strategy to Supplement Reserves

- A. The JPA will procure appropriate insurance coverages to protect, preserve and/or replace its reserve funds should an unanticipated risk event occur.
- B. When necessary and appropriate, the JPA should consider borrowing from other available funds, its member agencies or through access to the debt markets rather than draw upon its reserve funds. Any action to incur debt will be consistent with the JPA's Debt Management Policy.

#### **RECOMMENDATION:**

Approve resolution for Proposition 68 Recreational Trails and Greenways Grant application to request grant funds for the Osuna segment of the Coast to Crest Trail.

The Osuna segment of the Coast to Crest Trail is located near the community of Fairbanks Ranch between the end of the Surf Cup trail segment and the San Dieguito Road future pathway (Attachment 1). The planned trail segment has been a gap in the Coast to Crest Trail for many years. In 2015 the JPA conducted a feasibility study (funded with private donations by the San Dieguito River Valley Conservancy) for the trail gap that assessed alternative alignments for a bridge over the San Dieguito River as well as environmental and engineering constraints. A bridge is required to cross the river in this location to connect to existing and future segments of the CTC Trail further upstream. Although planning for this trail and bridge have been ongoing, including consulting and coordinating with stakeholders and securing a trail easement over a private parcel, funding does not exist to prepare engineering designs, secure permits, or construct the project.

The California Recreational Trails and Greenways grant program criteria is an excellent fit for the Osuna trail and JPA staff submitted a grant application on October 11, 2019 through this program. The JPA requested grant funds to pay for final engineering, CEQA, permits, and construction for a total grant request of \$1,397,800. The grant requires a 20% match (in non-disadvantaged areas) which is accomplished by a donation by the Conservancy (\$114,400), in-kind services, and additional JPA funds. The grant application submission is step one of a three-step selection process. If the JPA's project is selected by the granting agency (Natural Resources Agency), the JPA would be invited to step two which consists of a project site visit with granting agency staff. Step three (if selected) entails submission of additional project documentation including the subject resolution. According to the granting agency, the grant process is expected to take five months with grant awards to be announced in June 2020.

#### **Project Description:**

The project is to build a new 1-mile long segment of the Coast to Crest (CTC) Trail called the Osuna trail segment that will extend the trail, connect existing trail segments, and provide new public access to a waterway. The Osuna trail segment would extend the CTC Trail over a water way and connect it to a public road and future trail pathway. The project includes final engineering of the bridge, project permits, project construction, and habitat restoration (native trees and shrubs). The new trail segment includes a non-motorized bridge across the San Dieguito River, a natural watercourse with native trees within the San Dieguito River Park. The CTC Trail is a public regional non-motorized multiuse trail for hikers, bicyclists, and equestrians planned from the coast at Del Mar to Volcan Mountain near Julian in San Diego County. Approximately 48 miles of the planned 71-mile long trail have been completed.

- 6. Certifies that Applicant will work towards the State Planning Priorities intended to promote equity, strengthen the economy, protect the environment, and promote public health and safety as included in Government Code Section 65041.1; and

**SUBJECT**: Surf Cup segment of the Coast to Crest Trail

The segment of Coast to Crest Trail along the property formerly known as Polo Fields and now leased to Surf Cup Sports has been the subject of several years of delay regarding the trail's status and condition. The property, owned by the City of San Diego, was leased to San Diego Polo Club for close to 30 years and included a clause that the existing public trail would remain open to the public and would not be impacted by polo operations. When the Polo Club lease terminated a new lease was approved in 2016 to Surf Cup Sports. Surf Cup has been operating and holding soccer events at the site and made several "improvements" to the property particularly circulation and parking changes and new soccer fields.

The general timeline regarding the status of the public trail along the south side of the property (north side of San Dieguito River) is:

**June 2005**: Civil Penalty Notice and Order served on Polo Club by San Diego Neighborhood Code Compliance for "illegally grading a horse exercise trail area adjacent to protected wetlands and outside of the leasehold property line for the Polo Fields". Subsequent hearing ruled that Polo Club cease grubbing and grading of the property and submit a permit application for restoring the public trail and damaged wetlands.

**June 2011**: Polo Club received site development permit (SDP) from City to restore trail and wetlands (work covered under a CEQA Mitigated Negative Declaration approved by City in April 2011).

March 2012: Polo Club lease expired and continued on a monthly lease basis.

**July 2015**: City issued RFP for a new lease of property. RFP stated that new lessee would be responsible for restoring public trail and wetlands per the approved SDP.

**July 2016**: Lease to Surf Cup Sports approved by City. Lease mentions the public trail in several places and requires trail be open to public. Also recognizes recorded SDP for trail and wetland restoration as "covenant running with the premises".

**January 2019**: Grading permit issued to Surf Cup Sports for restoring trail and wetlands.

During the past 19 years the trail has been in various stages of accessibility. During the Polo Club's tenure the trail was unusable and not available to the public (public often asked to leave the premises). Currently, portions of the trail are overgrown with weeds,

sandy in spots, and not clearly delineated. The approved grading plans call for restoring wetland habitat along the edge of the river bank, delineating the trail, surfacing some sandy areas with decomposed granite, and adding trail fencing and signage. Because the permit conditions restrict construction and restoration activities to outside the bird nesting season the window of opportunity to accomplish the work is limited and urgent (mid-September to February).
